Topic: *Best Starts for Kids* is an initiative to improve the health and well-being of King County by investing in prevention and early intervention for children, youth, families, and communities. It will be the most comprehensive approach to early childhood development in the nation, starting with prenatal support, sustaining the gain through teenage years, and investing in healthy, safe communities that reinforce progress. As part of this approach, lead and other toxics in the home environment have been identified for investments. ## **Business**

### Updates

- Gail provided a synopsis of a presentation done by herself and Lorelei Walker at the Washington Public Health Association (WSPHA) at their annual conference in Wenatchee. ### Management Change

As this group has been discussing for almost two years, Gail has "new" job duties and is no longer able to serve as the organizer for CHE-WA effective January 2016. Many ideas have been generated, but to date, there has been no ready person or persons who have stepped up and into fill this role.

Several ideas were re-hashed including a walkthrough of a formal proposal by Arthur Wendel. Some guiding principles were agreed upon:

- Gail's work can be shared amongst people.
- Agreeing to step-up is for a year's worth of commitment; then others should rotate into the mix.

After much discussion a proposed plan was developed:

- Nicole Thomsen and Arthur Wendel could co-lead efforts for 2017.
